The newest facility for Believe in Talk is a house-like setting with two rooms. The center reports a Montessori-style educational setting with various opportunities for families to learn together as well as have fun. They have new sensory stations, water stations, and even sand stations for a variety of experiences.

Believe in Talk provides very personalized individual services to clients. Services are individually tailored to the child's needs, and they specialize in working with autistic and other special needs populations. Because clients are often in high crisis situations, they strive to be are available 24/7 to meet with GALs, attorneys, families, teachers, and clients.

Believe in Talk services are reportedly environmental and can also be off-site, as staff seek to work with children and families in their natural, most comfortable settings. The program offers therapeutic supervised visits in roller skating rinks, bowling alleys, Chuck E. Cheese, and even movie theaters when appropriate. Believe in Talk is proud of their record of reuniting children with parents with whom they've had very troubled relationships. Their director reports that their therapeutic approach has helped many clients rebuild their families.

Bougainvillea House has been in operation for 10 years and prides itself on a whole life and family approach to healing. It is more than just a supervised visitation center, with the licensed staff providing therapeutic visits and counseling in many different areas of concern based on client needs. Monthly family therapy is required for all participants as the goal is to achieve healthy family reunification. Once children are involved in counseling, counseling services are also open to parents in a variety of areas, from depression, anxiety, and substance abuse to parenting.

THe program director reports that their offices are open until 8:30 each evening to be sure kids don't have to miss school or perhaps their free meals. The center is a complex of five houses which provide a homey, more natural setting for visits. There are also yards to play in for outdoor fun.

Bougainvilla House does extensive community outreach, particularly in local schools to help educate students on mental health anxiety, depression, violence, substance abuse, self-harm, and other issues that may come up in the family setting. The program wants them to understand the issues and also know that services are available with all the resources they need to remain happy and healthy.

In addition to supervised and therapeutic visitation, the program offers-monitored exchanges. For the sake of safety, staff go out to the client's car to get the kids, then walk them in to the program. Keeping kids and custodians safe is a priority, and on-site security personnel are used as needed.

The Caribbean Community Connection believes that an educated community is a proactive community. Their mission is to foster and cultivate cultural ties to the Caribbean Community via socialization, education and community outreach projects and partnerships.

Caribbean Community Connection of Orlando, Inc. begun in September 2003 and is the only known Caribbean community-based service organization in Orlando, Florida to date. shopping with an officer. All gift certificates were donated by the Lake City PD and Walmart. Each child rides in a police car with the siren going as a 30-car convoy led by Santa goes to Walmart.

In-house, the program has a Build-A-Bear system. Each child begins by building an animal of their choice to keep and hold in therapy sessions. This is a friend they always have with them when things get rough. Throughout their sessions, they can get clothes for their animal as well. This is by far the kids' favorite thing!

This year the program is excited to continue with its extensive Christmas decorations. Many families come by just to see the decorations or take pictures in front of them. They participated in an event in Lake City – the Columbia County Baseballoween, which is a final tournament for peewee baseball as well as a festival. Chances for Children made cotton candy and snow cones for 400 kids.

The Family Visitation Center of the Children's Home Society serves the visitation needs of parents and children in the dependency court system of District 11, and has always done so

completely without charge to the parents. The program provides both supervised and therapeutically supervised visitation for families. They view as their greatest accomplishment the positive role they play in aiding in the re-unification of families and children by providing a safe, homelike environment for visitation.

The program typically has a constant stream of interns from the FIU School of Social Work, many of whom continue as hired staff after graduation. Although the program has returned to regular operations post-covid, they still offer toys that the children can simply take home with them, a practice begun during the pandemic.

CHS has instituted a new "Warm Line." As opposed to a "Hotline," this Warm Line is not just for emergencies but for any time someone needs to talk. The Warm Line offers 24-hour clinical services – someone to talk to. This service has been a great resource for the whole agency as well as SV clients. The project is going exceptionally well and is offered to not only CHS clients but the entire community. It is currently staffed by trained, licensed clinical staff from around the state.

Parents learn about brain development, so they have proper expectations for their kids. The parent education program also helps parents strengthen their own coping skills. This helps them understand their children's behaviors and how to manage those behaviors in a loving, appropriate way. Services are mainly in-person visits, but the program also offers virtual visits when requested. All visits are held in the Center.

The program recently moved to a new building, and has returned to activities such as holiday parties for the children. They decorated for the holidays to help families enjoy the season. Parents are encouraged to bring seasonal items and activities to the visit.

Children's Home Society provides visitation services to families who have children in out-of-home placements or active Dependency cases in Districts 9 & 18. The frequent nurturing visits will decrease the amount of time spent in out-of-home care by encouraging the family to maintain positive parent-child interaction and/or relationships to expedite the child's return home. The Visitation Program offers supervised visitation services free of charge to case management agencies. Children's Home Society of Florida's goal for the Family Visitation Program is to provide a safe, homelike environment for family visitation to children who are unable to remain safely in their homes. Any child who is removed from their parents undergoes trauma, even if the removal is necessary for the child's safety. The Family Visitation Program provides services that help parents maintain a loving bond with their children.

The program is operating as normal but continues to offer the option of zoom in certain cases such as when a parent is out of the area or the family is a COVID-19 risk case. Proudly the program has been able to provide families with needed resources through a Back-to-School supplies drive and looks forward to a upcoming Holiday gift drive. They report having an incredibly dedicated and talented staff who deserve a huge shout-out. Like many agencies, they have struggles with hiring staff for some positions, but report that their core staff has stepped up to ensure families are never aware of or affected by this. The program director emphasizes that staff have taken on added duties with grace and perseverance, and are very loved!

This center also features an inviting, homelike place with playrooms, a kitchen, living areas, conference rooms, and a playground outside -a more natural environment than the average case worker's office. Because of the warmth of the center, they report having been very successful in making families feel comfortable to really enjoy time with each other. The director reported a success story: One parent who was doing visits in a caseworker's office was really struggling – her numerous kids were antsy, sometimes noisy, and the whole situation was stressful for her. She even started missing visits. However, when this family moved to our center, they began to thrive. There is plenty of space for the kids to run about, play outside, find engaging toys and activities to do together. Now, this client is really succeeding and loves her visits!

The program reports other resources to make it a "perfect homelike place for working with clients. We have opened our center to therapeutic visits and parental fitness evaluations because it is much easier to get a clear picture of parenting and psych skills in our more natural, homelike environment."

The Camelot Family Support Workers provide additional support for case management and to families by allowing them to reconnect with their children and fostering a positive environment for families to bond. As an arm of the court and an in-house service provider, Family Court Services is in a unique position to serve families. Family Court Services directly assists the judiciary and provides many services tailored to the family's individual needs at no cost. This includes services such as co-parenting, assistance with time-sharing, crisis intervention, parenting coordination, and supervised visitation.

When COVID impacted the entire world, Family Court Services had no choice but to transition their in-person service onto the Zoom platform. In 2022, the office finally reopened its inperson supervised visitation program. Family Court Services currently offers Judges and families both in-person and virtual visitation, depending on the family's needs. With cases referred for 12 visits, one hour per week, Family Court Services was available to provide parent/child access (on-site and Zoom) to nearly 300 families in 2023. Without Family Court Services, many children would have remained estranged from their parents as there is no other safe, responsible, and reliable location for these families to stay in contact.

With Family Court Services being a central resource for the judiciary, the unit has assisted in promoting and facilitating proactive trainings with a comprehensive curriculum for the legal and mental health community focusing on professional boundaries, ethical dilemmas, rules of engagement, and risk-management strategies. In 2023, Family Court Services coordinated

and conducted six 4-hour training courses specific to the following professionals/providers: supervised visitation, social investigators, parenting coordinators, psychological evaluators, quardian's ad litem, and counselors.

Program administration reports that "wonderful and resilient staff have done a terrific job of balancing in-person and virtual visits." In one case, a mother was genuinely concerned about her baby being exposed to COVID-19, so the program agreed to have her in-person visits outside regular hours when no other families were around. This case continues with great success!

The program continues to use virtual visits in additional ways. Judges sometimes order virtual visits *before* allowing in-person visits as a transitional option. In some cases where there is a strained relationship, this allows the program to move slowly to in-person visits. It has been a wonderful solution in several cases. In one case where the last interaction of the parent and child had been tense and uncomfortable, they were able to do a series of virtual visits to work through some issues before actually visiting in person to enjoy each other's company. In another case, a mother and her young baby are doing virtual visits with extended family members so the child can see and meet them before seeing them in person. This strategy allows the child to acclimate gently. In yet another case, the child refused to visit in person but agreed to virtual visits. Through a series of virtual visits, the child and parent were able to reconnect gently and then move to in-person visits. The program is proud to report that this family is now happily reunified! Judges will continue to utilize virtual visits this way, and the program continues to offer it as an option for cases.

This coming year, the program will work with a judge's request to video tape visits. This will be a new endeavor, and the program is working to keep the camera non-intrusive.

The program is proud to decorate seasonally and with each holiday. They are now transitioning to Christmas, when they plan to host a Gingerbread house decorating contest. In addition, they will make goodies bags for each child to take home for the holidays.

The Visitation Coaching Program serves the supervised visitation needs of parents and children in the dependency court system of Circuit 5. There is no charge to the parents. The program receives referrals from case management and recommendations from the court to highlight the areas of need. There are currently 2 visitation coaches with extensive experience working with families. One is bilingual, who speaks Spanish and English. The Visitation

Coaching program provides the children and parents with books, puzzles, board games, and a variety of activities to make the visits a positive experience. The parents are encouraged to provide food for the children and talk while eating together to enhance and rebuild their bond. An important component during the pre-visit and post-visit is to allow the parents time to discuss their thoughts and feelings, discuss any barriers, and plan an activity for their children. Materials, videos, and modeling are tools used to enhance diminished protective capacities. The visitation coaches offer suggestions for age appropriate engagement and ways to strengthen the bond with their children. The parents are encouraged to put the children's needs first.

Before starting any services, an agreement is signed by the parents and coaches to emphasize the expectations and guidelines within the program. The coaches participate in staffing and court hearings regarding the parents' case plan goals and tasks needed to achieve reunification with their children. The program is approved for 10 visits, but an extension or brief assessment may be granted based on the individual families' needs and progress. Due to Covid-19, visits by Zoom were added to facilitate parent-child contact and continue to be used if one or the other is sick or residing out of state.

The visitation coaches provide creative ways to reassure and inspire parents to continue visiting and planning for their child's permanency. In many instances activities are provided that are age appropriate by bringing them to the visits or providing them at our visitation rooms. This is to show the parents a variety of activities that the child may enjoy and utilize. On some occasions, the program staff give toys to children as they leave the visit, so the ride back is not as stressful for them. TBRI strategies are used to empower parents to build connections and build trust with their children to have more success in behavior correction and discipline. They often give information to parents about services in the community to address specific needs like DV shelters, government funded apartments, daycare services, etc. Additionally, they also inform staff about our program and give suggestions on how to assist other families in the agency.

The Visitation Interaction Program is designed to strengthen and/or repair the relationship between parents and children in and out-of-home care where reunification is the goal, and the court has ordered visitation. It focuses on making visits child-centered, with the parents engaging in a positive manner with the children. It also allows visits to occur in the most homelike setting possible. Staff are available during normal business hours, but services to families are provided at dates and times that best suit the families and their schedules.

Through the Visitation Interaction Program, parents learn how to make visits a positive experience. They learn techniques and are provided tools to help them meet the needs of their children. The Program is intended to strengthens the child's relationship with the parent.

The coaching process begins with the completion of the Adult Adolescent Parenting Inventory, which provides an index of risk in 5 domains: expectations of children, parental

empathy towards children's needs, use of corporal punishment, parent-child family roles, and children's power and independence. The AAPI is completed before working with the family and at the conclusion of the Program to measure progress.

Each visit consists of a pre-visit prep session where the coach and parent develop goals for that day's visit, observation and coaching during the visit on areas identified as needing improvement, and a post-visit feedback session to discuss where the parent did well and needs more coaching.

Since program inception, AAPI scores reflect an overall average improvement of 1-5 points in each domain for clients. Customer satisfaction surveys reveal parents enjoy having their visits outside of the office and developing a stronger bond with their children. The Program has also shortened the length of stay in and out-of-home care, and increased the likelihood of the child being reunified (versus families not involved in the Program).

The Visitation Interaction Program was the recipient of the Innovator of the Year Award at the Children's Home Society of Florida's 6th Annual Innovation Symposium in 2012. The Symposium is dedicated to finding better ways to serve children. This Program was selected due to its successful outcomes and ease of replication.

The program hosts a special Thanksgiving drive to provide dinner for families in need and a toy drive to give presents to children who might not otherwise have Christmas gifts. In addition, they collect bookbags and school supplies for kids and are part of the Bags of Love network helping kids 1mo to 18 years old which includes bags with a pillow, comforter, a stuffed animal, personal supplies, and etc., to make sure they feel loved and comforted. Finally, the program collects donations for families' new homes such as dishes, housewares, and furniture.

Peace Club has been in operation for 6 years and has tremendous support from the area's family court judge, Judge McKinnen. Program director Tyna Baugess emphasizes that judge McKinnen is an advocate for families and is very proactive about assigning them to many services that help and encourage their reunification when possible.

The visitation center is on the beach which gives staff the unique opportunity to hold visits, mindfulness activities, and group sessions right on the beach. The program director says: "This is very soothing and as some say, very Zen. Our center is nicely decorated and has been described as "spa-like" which helps promote an atmosphere of calm and peacefulness."

The program typically does intake sessions at the office, but most of visits are out in the community, in a more natural family setting. Some visits are in-office if parents are really struggling. The program director explained: "Once we had a cancellation and when I spoke with the mother, she admitted that she didn't show up because she had no money for food or snacks. We will never let that happen again! We always supply pizza, snacks, or any food needed to make visits run smoothly!"

One barrier to service is often transportation but the program has been working hard with partners to ensure all family transportation needs are met. The program curriculum involves the assessment of ACES first and then gathering information from the visiting parent. They emphasize observation and encouragement as well as therapeutic visits. A major focus of visits is parent education and mirroring to show parents a positive way to interact with children.

All services are offered on a sliding scale based on income. Contracted services from foster care, CBC's and other agencies are modest and fair. Service is always expedited, generally no more than a 36-48 hour wait for most case requests. Staff help parents schedule visits.

The Toby Center Team follows court orders first and will otherwise help parents to jointly determine their goals where possible. The goal is to work collaboratively, as research shows that when both parents are engaged in a consistent and loving relationship, children will best thrive emotionally and socially. Many of Toby Center's team members are parents themselves and are committed to helping improve co-parenting opportunities and help families move forward more comfortably during this difficult period.

A researcher and child custody expert, Dr. Mark Roseman is the Founder/CEO of the Toby Center and has worked with children and parents since 1998 when he became the Assistant Director for Child Access for the national Children's Rights Council in DC.

Thriving Families offers a chance for reunification of child(ren) and their parent and/or other family members under the circumstances of divorce or the absence of the parent or otherwise. Thriving Families was developed so children can have a safe, secure place to rebuild broken bonds when supervised visitation has been court-ordered. The Buggy Bunch has implemented a system with the Thriving Families program where a supervised visit or exchange is provided with proper security by a paid law enforcement officer. In addition to

security, TBB provides trained facilitators who observe through sight and voice and in a secure atmosphere during the supervision period.

Referrals for the program usually come from the 19th Circuit Judicial Court System. The visitation between the non-residential parent and the child lasts for 1-2 hours and is either weekly or biweekly. The Learning LOFT is provided at The Buggy Bunch Family Center for the non-residential parent and child to use. Contact between the residential parent (RP) and the non-residential parent (NRP) is not permitted. This is accomplished by staggering the time for drop-off and pick-up of the child, overseen by the security officer. Thriving Families also offers a court-ordered Monitored Exchange Service that allows parents to make safe exchanges for their children. Benefits include shared parenting time, reduced stress for parents and children, security, and a neutral third party.

As a Court-Ordered Supervised Visitation Program, Thriving Families makes it possible for parents to receive safe and secure visitation with their child(ren) in one of three ways: one-to-one supervision, monitored exchanges, and/or group supervision. This is accomplished through striving for best practices and achieving our primary goals, which are: 1. Secure Visits, 2. Nurturing Atmosphere, and 3. Education and Awareness.

This much needed program was created and exists for several reasons: to build parent capacities, to provide parents with evidence-based research and strategic plans, to implement the Six Protective Factors established by the Clearinghouse on Supervised Visitation and to give parents developmental skill-building plans to strengthen and improve family bonds and relationships.

Twin Oaks Community Services (TOCS) oversees the Visitation Center for Bay County, FL. In collaboration with Northwest Florida Health Network, the program is working on a renovation of the temporary visitation rooms. Currently, there are four large rooms and eight small rooms to facilitate visits. When fully renovated, there will be twelve fully furnished visitation rooms that promote a healthy environment and privacy for families. Currently, the contract allocates one full-time supervisor and seven full-time Visitation Specialists. TOCS Visitation Center's current staff consists of one full-time supervisor and five Visitation Specialists, with two in the hiring process. There are approximately 70 families and 135 children being served. TOCS is in the process of identifying barriers behind cancellations to promote healthier outcomes. # Case and Client Statistical Analysis Results

# October 1, 2022 to September 30, 2023

Federal Fiscal Year

In this report we present the results of the annual Clearinghouse on Supervised Visitation's Database Case and Client Analysis. This report covers October 1, 2022 to September 30, 2023, the 12 months since the last report. A total of 50 supervised visitation providers in Florida contributed information to the database during this timeframe.

For the year, from 10/1/2022 to 9/30/2023, the total number of documented cases utilizing supervised visitation programs was 1,821, (up approx. 9%) the number of clients served was 7,610 (up approx. 15% - 3,412 children, 2,150 visitors, 2,048 custodians/others), and the number of services provided was 33,641 (up approx.18%.) This is the number of completed or terminated services only, and does not include intake sessions, scheduled but cancelled services or no-shows.

The newest variable (2020) is a variable denoting whether the visitor or custodian for each case is participating in the Florida Child Support Program. As this question is added to more intake forms, we have consistently obtained more data — the 2020 report had only 38 entries while the 2021 report showed 181 entries and the 2022 report has 232 entries. This year, we have 1,469 entries. We expect this to continue to rise as sites revise their intake forms and processes to reflect this item.

The amount of missing data has *continued to decline* over the last five years. This may be because of the Clearinghouse training on the database, periodic reminders to programs to enter all data correctly, and requirements within the database to enter specific information before being allowed to move forward.

<u>Percent vs. Valid Percent</u> - The percent shown in each table is the percent of the total number of cases showing one particular answer, factoring in any cases for which the data is missing or is zero. The valid percent is the percent of the total number of cases showing one particular answer but *not including* any cases with blank cells or missing data. If there are no missing data for a particular variable, then the percent and valid percent will be identical.

The following are the 2023 findings.

# Referral Source

In the database, there are seven options for the variable Referral Source. This is a mandatory variable in that database users cannot continue until this information is inserted. **Mostly, the trends have remained steady as dependency court continues to be the most common referral source.** Domestic violence cases account for the next largest source of referrals remaining steady from last year at 7%.

# Reason for Referral (Condensed)

For each case, multiple reasons can be cited for the referral to supervised visitation. However, the database user is required to enter one primary reason for the referral first. The percentage of primary domestic violence **cases increased from 31% to 37.5%** this year, while the percentage of primary substance abuse cases dropped from 41% to 38%. The percentage of child abuse/neglect cases remained the same.

Programs may identify that one factor behind child abuse/neglect may be domestic violence or substance abuse. Remember that this is the *primary reason for referral* and may reflect only the main issue of the case as noted in the referral document.

# Additional Allegations

The table below lists the allegations noted **in addition to the primary allegation** or reason for referral. As many items as needed may be checked for each case. While 38% of cases this year were referred to supervised visitation primarily for parental substance abuse, 16.7% of the remaining cases listed parental substance abuse as an additional allegation, so **54.7% of all cases reported substance abuse** as an issue. Similarly, while 5.7% of cases had parental mental health as a primary reason for referral, 10.8% of cases listed it as an additional issue which adds up to 16.5%. Combined, these two issues are present in 71.2% of all cases.

Also of note is 37.5% of cases listed DV as the primary reason for services, and 15.2% of the cases also listed it as an additional allegation, meaning **52.7% of all cases had DV as a component.**

# Primary Service Requested

This chart identifies the primary service for which the client was referred. The most common reason for referral remains supervised visitation followed by parent education services which may include parenting classes, one-on-one parental education and training, or parent services. **Most clients also receive parent education and assistance as a secondary service.** The number of monitored exchange cases dropped over the last year and fell to a new low once again this year.

The number of supervised phone visits listed as the <u>primary service</u> was 0%. Some centers continue to offer phone or virtual visits if needed, however, they are no longer a primary service.

# Description of All Services

The chart below identifies the distribution of service types provided to clients. The most common service remains supervised visitation. This year saw a continued but slight decrease in virtual visits (5% down to 4.3%) as programs fully returned to in-person

visits. So, while it was not listed as a primary service for any cases, programs are still utilizing virtual visits when requested or required.

# Person Providing Service

# Visitor's Gender

The following data represents information on the *primary* visitor in each case. The visitor is typically someone who does not have custody of the child, but the person with whom the child will have supervised visits. So that all parental visitors can be counted, the Clearinghouse encourages programs to have a separate case for each non-custodial parent that is visiting children. However, cases with two parents visiting but not

separated, as well as additional visitors such as grandparents, siblings, and other relatives, account for the additional 329 visitors.

In the last decade, men and women were almost equally represented as visitors participating in supervised visits. Since 2018 the percentage of women has increased steadily from 60% in 2018 to 67% in 2022 and dropped slightly to 65% in 2023. This likely reflects that most cases are dependency cases.

Some cases show both parents as non-custodial visitors, and the Clearinghouse encourages database users to separate those cases into two different cases, one for each parent. Most additional visitors that are parents, are stepparents visiting along with the visiting parent.

## Visitor's Annual Income

As in previous years, the majority of primary visitors are below the poverty level – approximately 72% below \$20,000 and perhaps as much as 85.4% if the family poverty line is used (includes less than \$29,999 category). The number of visitors in the lowest category dropped for the first time since 2017. The category with the highest gains was the \$40k and above category.

Women were the most common *primary* custodian, the person having legal custody of the child client. This may be in part because most Foster Parents are listed as females. Additional custodians (227) may include a custodian's spouse, stepparents, siblings, and grandparents, among others.

# Custodian's Race

The majority of the custodians continue to be white clients. However, the number of custodians identifying as Two or More Races has increased steadily and is up from 4.3% to 6.5%.

Previously, the most common primary custodian was a parent to the child client; however, parents as custodians have been steadily dropping as Foster Parents as the Custodian has risen. This year, Foster Parent (39.5%) supersedes Parent as the most common caregiver (20.3%). Following Foster Parents, Parents and then Non-custodial Relatives were the most common custodians.

### Custodian's Income

There is often some missing data on the custodian's income since many programs and case managers do not have access to this information. This year most programs have added Custodian Income to their intake forms. Therefore, the number of unknowns fell to just 35. The number of custodians across the range of incomes has been relatively similar. However, this year, the \$10k - \$19k shrunk considerably while the \$20k – 29k and \$40k and above categories increased. It appears that almost 27% (down from 38%) of the custodians earn less than \$20,000 per year. With federally designated poverty levels at \$27,750 for a family of four, more than half of custodians fall beneath the poverty threshold.

# Florida Child Support Program Participation

The newest variable added to the database in 2020 was inquiring whether the Visitor or Custodian was participating in the Florida Child Support Program. With most sites now including this variable in their intake forms, the number of missing data points has steadily fallen. The category of *Don't Know* dropped from 63% to 21% over the last three years.

# Domestic Violence Reporting

In each case, the person entering data is required to note whether domestic violence was a component of, or was present in the case upon intake (according to the referral). In 2021, 42% indicated **YES**, up from 38% in 2020. However, 2022 saw a significant drop, with 31.6% of cases reporting domestic violence. In 2023, the number has returned to previous levels, with 52.7% of all cases including DV as a component.

# Unexpected Incidents: Disruptions in Service

An *unexpected Incident* is a disruption in service: an event that occurred before, during, or immediately after the service was initiated, that was unusual or problematic, and may have required monitor intervention, the cancellation or termination of the service, or the removal of the offending party from the premises.

The purpose of this variable was not only to identify dangerous situations, but also to learn what more minor problems might be occurring during visits that require attention. In 2020, the rate fell to only 87 critical incidents, or 5.1% of cases. This may be because, for almost six months, most programs were only offering virtual visits. In 2021 and 2022, the numbers rose again with the return of in-person visits and the inherent risks associated with them. In 2023, the number of incidents dropped slightly.

The Clearinghouse continues to emphasize the need for enhanced safety measures and consistently offers support and training on the issue of safety in supervised visitation.

In 2023, the number of unusual incidents dropped somewhat. Visitors refusing direction and children refusing to participate are the most common issues.

The generally low number of unexpected incidents may reflect staff training of Florida's SV programs. Unexpected incidents have the potential to be dangerous. Proper security measures are always necessary at programs.

Below are the noted actions taken in each case experiencing an unexpected incident. Several actions might have been taken for a particular incident, therefore allowing for a higher number of actions than incidents themselves.

### Cancellation of Visits

Scheduled visits are often canceled before they can take place. Below is a cumulative list of those responsible for canceling services. Most often, the visit is cancelled by the visitor for various reasons. In 2023, cancellations are up from 6,565 in 2022 to 9,761 in 2023.

Reasons for cancellation are varied and listed below. Often, no reason is given. Approximately 18% of all scheduled services were No-Shows. Also of note is the number of services canceled for Non-Confirmation: 755. Many sites require confirmation of the visit to ensure their program resources are not unexpected no-shows.

From 2022 to 2023, Cancellations Due to Weather were up more than double, as was Child Refusal to Visit. However, cancellations due to staff resources dropped from 228 to 8.

# Case Closures

In the 2022-2023 analysis period, 894 cases were closed. It is noteworthy that programs often forget to close cases, especially if clients simply stop coming over time. The Clearinghouse has made an effort to remind programs to review and close cases that are no longer active.

The number of cases closed for safety reasons dropped in 2020 and 2021 but increased back to 6.4% in 2022. In 2023 the number of cases closed for Safety Reasons decreased (as did the number of cases closed for Refusal to Pay Fees and Child Refused to Visit.) The reason for this decrease is unknown.

### Closure Variables

When closing a case, programs are asked to report on substance abuse and arrests for violent crime before, during, and after the completion of services. If the program answered yes, they were provided the opportunity to expand on their information. Below is the summary of this data from the 894 cases closed this year and the percentage of closed cases the numbers represent.

### Substance Abuse

About 38% of clients came to supervised visitation this year with substance abuse as their *primary* issue. Almost 16% of new cases also listed substance abuse as an *additional* allegation, meaning 54% of cases named substance abuse (SA) as an issue for supervised visits. Note that many programs do not have the resources available to track clients after they leave.

### Arrests for Violent Crime

In the 894 cases that programs **closed** in the 2022-2023 year, 5% of cases included a client who had been previously arrested for a violent crime. However, the percentage of those perpetrators becoming violent during supervised visitation services is low.

While the number of known offenses after case closure reported is only 2, this may be due to the fact that many programs do not have access to records after their clients complete services.

# Implications and Recommendations

The steady increase in dependency cases in Florida's supervised visitation providers and the small number of family court cases that serve families reflects that **fiscal** resources for supervised visitation are being directed to dependency cases, not family court cases.

This is troubling because when courts need the services of family court supervised visitation, those resources may not exist. Judges may feel compelled to allow untrained family members and friends to provide oversight in dangerous cases, leaving children

vulnerable. Trained program staff offer the most attention to safety. Or courts may allow unsupervised visits in cases where a parent is violent because there are no local resources for supervision.

No new funding for Florida's SV system has been created by the legislature or supported by the courts in decades. Most existing funding is from the Department of Children and Families from a federal grant (called the State Access and Visitation grant). Most of these funds are distributed to the Community Based Care organizations, who typically the funding to support dependency cases. Programs also receive some small amount support from local philanthropic organizations.

The need continues for increased program funding as well as the implementation of standards statewide for supervised visitation programs and monitored exchange programs throughout the state.
